TERMS AND CONDITIONS

FEES

- 1) Fees are due in full on or before the first day of term in September, January and April. Non-payment will result in refusal of admission
- 2) In the event of late payment of fees, the School reserves the right to add a further charge to the term's fees of £50 per week after the first day of term in September, January and April until payment is received. You will be notified of this additional charge in writing.
- 3) Fees may be paid monthly through the School Fees Plan operated by Premium Credit Limited. Information is available from the Bursar.
- 4) The School Fees are subject to alteration, but at least one term's notice of any changes will be given.
- 5) There is no remission of fees on account of absence through illness or any other cause.

WITHDRAWAL OF PUPILS

- A full term's notice in writing is required before the removal of a pupil and a full term's fees must be paid. For the avoidance of doubt, if you give notice part way through a term that you wish to withdraw your child from the School, the rest of that term's fees will be payable together with the following term's fees as well. Please note if the School refuses to admit any pupil for any term (or part thereof) based on non-payment or late payment of fees then, in such circumstances, notice to withdraw that child will be deemed to have been served by the parent/carer and payment of the full term's notice shall be required as set out above.
- 2) The Headteacher reserves the right to require removal of any pupil for unseemly conduct or a consistent lack of application to studies, or for any other reason which she deems to be in the School's best interest using her discretion. Should any of these situations arise, there will be no refund of any part of the then current term's fees and a full term's fees will be due in notice monies as in para 1 above.
- 3) In the event that any fees or notice monies are outstanding, this may result in the Board of Governors exercising their discretion to take legal action for the recovery of such fees via the County Court.

DECLARATION

A payment for the non-returnable registration fee of £250 is enclosed.
